Detail Terms and Conditions of the Tender Call Notice

1. Sealed Tender shall be in plain paper/letter pad of the intending registered firms/suppliers located at Bhubaneswar. Supply of items listed

above from 01 to 10 are for use in Home Department. The Tender shall be submitted in prescribed format appended herewith.

2. The tenderers shall mention the VAT/TIN/SRIN Number in their tenders and furnish the copies of up to date VAT Certificate in Form VAT-612.

3. The tenderer shall deposit earnest money @ of 3% of tender amount of the concerned article(s) in shape of A/c Payee Bank Draft/Pay Order payable to the D.D.O.-cum-Under Secretary to Government, Home Department which will be refunded to the unsuccessful tenderers whose tenders are not accepted.

4. The tenders (along with samples of the item where ever practicable) should reach the undersigned by 02.03.2010 up to 3.00 PM at the latest and they shall be opened on the same day at 4.00 PM in the presence of tenderers or their authorized representatives (one representative for each tenderer). The rates of different items may be furnished separately.

If the firm/supplier becomes unwilling to honour after it is selected in the due process, its EMD shall be forfeited.

5. There shall be no over writing on the tender paper submitted.

6. The tenderer shall submit the tender in the prescribed format as given below.

- 7.. The rates quoted shall be inclusive of all taxes, transportation and delivery charges. The rates quoted should be valid for one year counted from the date of issue of supply order.
8. The bid submitted cannot be withdrawn.
9. The authority reserves the right to reject all or any tenders without assigning any reason thereof. The tenders received incomplete or after the scheduled date and time shall be rejected.
10. Authorities are not bound to accept the lowest financial bid.
11. On delivery, the supplies or product shall be inspected to verify the quantity/specification/quality for which the order was placed. If it turns out to be otherwise, the acceptance of delivery shall be refused at the risk and responsibility of the supplier.
12. All the transit risks shall be the responsibility of the supplier. Price quoted shall be F.O.R. delivery in Home Department premises.
13. Failure to supply the order in full within the stipulated period may lead to forfeiture of EMD and black listing of the suppliers.
14. The suppliers shall give a "Performance Warranty" for a minimum period of at least one year or as per the company warranty period (more than one year).
15. The suppliers of item like photo printer and Colour Laser Multi Functional Device should furnish authorized dealership certificate from the company, should quote their rates for Annual Maintenance Contract for a minimum period of 03 years and should furnish an undertaking for availability of spares of the equipment for total 5 years from the date of supply.
16. No advance payment shall be made to the successful bidders.
17. All the disputes shall be subject to the jurisdiction of civil courts situated at Cuttack/Bhubaneswar.


